

STUDENT REQUIREMENTS CHECKLIST: DANCE CHOREOGRAPHY

****Upon completion, sign this checklist verifying that all rules and guidelines have been read and understood. STAPLE completed form to the back of your Student Entry Form**

The recorded performance **SAVED AS A FILE** on the DVD/CD, not as a DVD/CD movie.

Student Entry Form completely filled out, including:

1. Student's complete contact information

- Student's full name/Student's address/Student's phone number/Parent's email address
- Original signatures of student and, if student is under 18, parent/guardian

2. Required Information Answered:

- Stated who performed the choreography and credit the background music.

3. Music

- The title, composer, and performer of any background music must be credited and documented on the Student Entry Form. If the entry's connection to the theme is expressed in the song choice, this should be explained in the artist statement.

4. Required Artist Statement:

- Describe what inspired you to create this work and how it relates to the theme. This is required for all grade divisions. If additional space is needed, use the back of the Student Entry Form or an extra sheet of paper. **BE SURE TO WRITE YOUR NAME ON ANY ADDITIONAL PAGES.**

5. Title

- Included the title on the Student Entry Form- If the entry has no title, please write "Untitled."

Presentation:

All grade divisions **must submit a DVD or CD** of a performance of the choreography. ****NO CASSETTE TAPES ACCEPTED****

- Entry DOES NOT EXCEED 3 Minutes**

**** Required Artist Statement: **New Requirement***

- State your artist statement at the beginning of the recording** (the artist statement is not considered part of the three **minutes of the entry**).

Format:

- A SUBMISSION IS in one of the following file formats:**

The recorded performance **SAVED AS A FILE** on the DVD/CD, not as a DVD/CD movie.
